- The paid-up share capital of the Company is reduced from Rs. 10,00,00,000/- consisting of 10,00,00,000 equity shares of Re. 1/- each to Rs. 35,00,000/- consisting of 35,00,000 equity shares of Re. 1/- each. The Hon'ble Bombay High Court approved the said scheme of reduction on November 29, 2013. The Company has filed the listing application with BSE on February 26, 2014 the approval for which is awaited for the exchange.

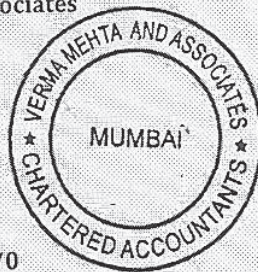
